

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is 2202 Oakland, Inc

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 2216 E. Oakland Park Blvd. Fort Lauderdale, Florida 33306

ARTICLE III - PURPOSE
