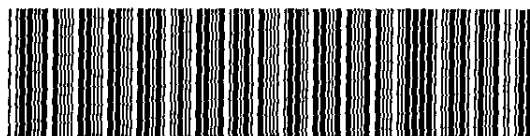

I, the undersigned, being desirous of forming a corporation for profit purposes, pursuant to Chapter 607 of the Florida Statutes, do hereby recite the following:

ARTICLE I: CORPORATE NAME AND ADDRESS




