AMENDMENT TO THE ARTICLES OF
INCORPORATION
OF
ROAR GROUP INC.

'BEFORE ME, the undersigned authority, this day personally appeared Osvaldo J. Diaz who first by me being duly sworn deposes and says:

That pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

First: Be it amended that Article I of the original Article of Incorporation has been changed to Gables MRA, Inc..

Second: Be it amended that the original Articles of Incorporation have been changed to delete *Osvaldo J. Diaz as President / Vice-president / Secretary / Treasurer / Director* of the company.

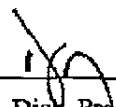
Third: Be it amended that the corporations officers are hereby changed and will be known as Robert Diaz President / Vice-president / Secretary / Treasurer / Director of the company.

Fourth: Be it amended that the stock ownership of the corporation has been changed to remove Osvaldo J. Diaz with 100% of common stock.

Fifth: Be it amended that the ownership of common stock has be changed to Robert Diaz as 100% owner of common stock.

Sixth: The date of the change of officers shall be effective on the date filed in the Office of the Secretary of State, Division of Corporations, State of Florida. This is adopted the 20th day of June 2003.

Seventh: The amendment was approved by the shareholders. The number of votes cast by the shareholders was sufficient for approval.
