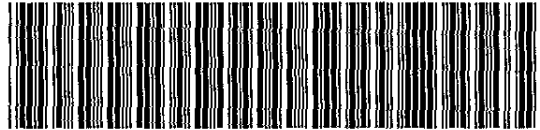


ARTICLE IX - AMENDMENT


