

ARTICLE I

The name of the corporation shall be MILOUST CORPORATION and its mailing address shall be 2316 NW 15 Court, Fort Lauderdale, Florida 33311.

ARTICLE II

This corporation shall have perpetual existence commencing upon the filing date of these Articles of Incorporation with the Secretary of State of Florida.




