

ARTICLES OF INCORPORATION

OF

SOUTH BROWARD REHAB & MEDICAL CENTER, INC.

ARTICLE ONE

The name of the corporation is SOUTH BROWARD REHAB & MEDICAL CENTER, INC. The principal address of the corporation is:3200 \overline{N} .E. 14th Street, Pompano Beach, Florida 33062.
