ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

OLD HARBOR BANK

(Florida Divisions of Corporation Document Number P03000016871)

Pursuant to the provisions of section 607.1006, Florida Statutes, Old Harbor Bank, a Florida profit corporation, adopts the following amendment to its Articles of Incorporation:

FIRST: Article III of Old Harbor Bank's Articles of Incorporation is amended by deleting the present form of Article III in its entirety and by substituting, in lieu thereof, the following:

ARTICLE III

Capital Stock

The total number of shares of all classes of capital stock which the Corporation shall be authorized to issue is 50,000,000, of which (i) 49,000,000 shares shall be common stock, having a par value of \$1.00 per share ("Common Stock"), and (ii) 1,000,000 shares shall be preferred stock, having a par value of \$1.00 per share ("Preferred Stock"). The Board of Directors is authorized, subject to limitations prescribed by the Florida Business Corporation. Act and the provisions of these Articles of Incorporation, to provide, by resolution or resolutions from time to time and by filing a certificate of designations pursuant to Florida Business Corporation Act, for the issuance of Preferred Stock in series, to establish from time to time the number of shares to be included in each such series, to fix the power, designations, preferences and relative, participating, optional or other special rights of the shares of each such series and to fix the qualifications, limitations or restrictions thereof.

SECOND: The date of the amendment adoption is January 5, 2010.

THIRD: The amendment was adopted by the shareholders. The number of votes cast for the amendment by the shareholders was sufficient for approval.
