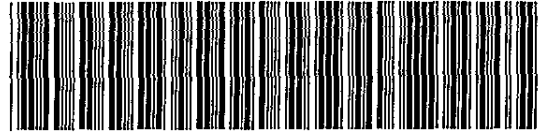



ARTICLE I. NAME

The name of this corporation is BECHDEL INSURANCE AGENCY, INC., doing business at 1635 South Ridgewood Avenue, Suite 202, South Daytona, Florida 32119.
