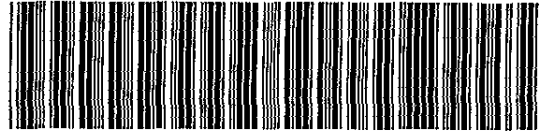


ARTICLE IX




