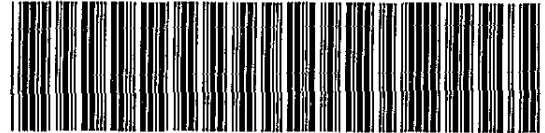

of the Florida Statutes, adopts the following Articles of incorporation for such corporation:

ARTICLE I - NAME

ARTICLE II - PURPOSE


