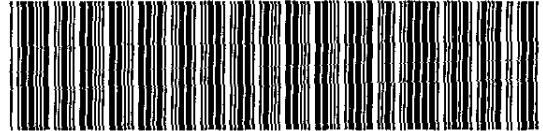

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is MIKE'S CONCRETE PUMPING,

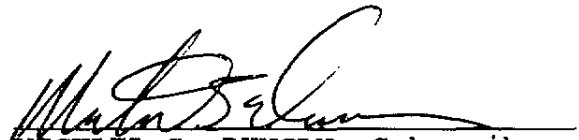
