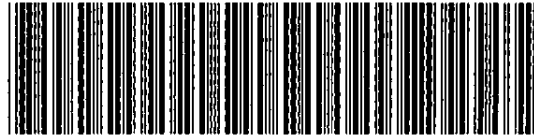

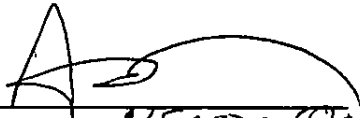
LETTER OF INTENT

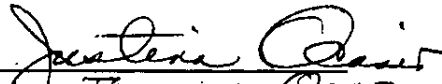
To all persons of concern, let this letter serve as our intention to change the name of Al & Tina Fitness Center, Inc. to:
