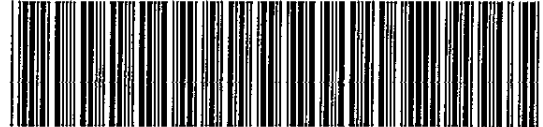



A + MOTOR SPORTS, INC.


