

ARTICLE I - NAME

The name of this corporation is TO DIE FOR! OF ST. ARMANDS, INC.

ARTICLE II - TERM

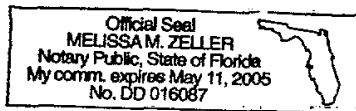
