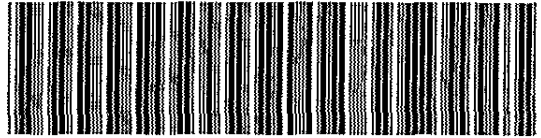

The name of this corporation shall be HENSLEY PHYSICAL THERAPY SERVICES, INC.
