The Undersigned Incorporator, for the purpose of forming a corporation pursuant to Chapter 607 of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

3. To do such other things as are incidental to the foregoing or necessary in order to accomplish the foregoing.

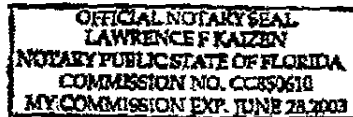
