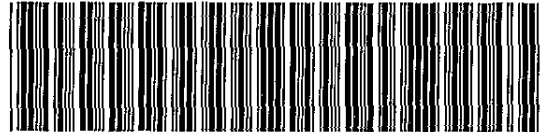

ARTICLE I

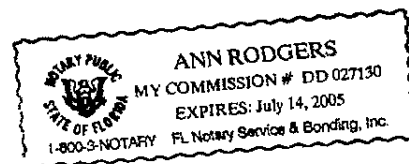
