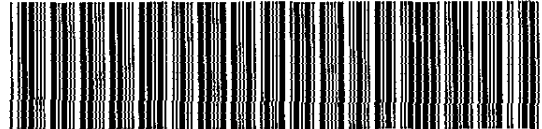

ARTICLES OF INCORPORATION

OF

JAMIL RECORDS AND MUSIC, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME.

The name of this Corporation shall be Jamil Records and Music, Inc.

ARTICLE II. COMMENCEMENT & DURATION.

The existence of the Corporation will commence upon filing as provided by the laws of the State of Florida, and will continue thereafter perpetually.

ARTICLE III. PRINCIPAL OFFICE.

The principal place of business of this Corporation shall be 10420 Bonita Beach Road, Bonita Springs, FL 34135, and its mailing address shall be 3265 Royal Palm Avenue, Fort Myers, Florida 33901.

ARTICLE IV. NATURE OF BUSINESS.


