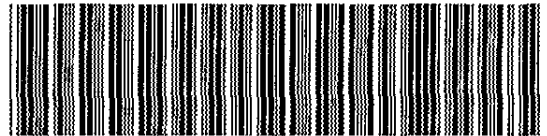

I.

NAME

This corporation shall begin on the date of its incorporation and exist perpetually.
