The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, Florida Statute 607, adopts the following Articles of Incorporation for such corporation:

1. **NAME.** The name of the corporation shall be:
MURPHY ASSOCIATES REALTY, INC.
2. **DURATION.** The corporation shall have perpetual duration,
except as the same shall be dissolved as provided by law.
3. **PRINCIPAL OFFICE.** The principal place of business and mailing
address of the corporation shall be:

4. **PURPOSE.** The purpose is to engage in any activities or
business permitted under the laws of the United States and the State of Florida.
5. **CAPITAL SHARES.** The corporation is authorized to issue up to

corporation shall have ONE Director initially. The number of Directors may either be
increased or decreased from time to time by an Amendment to the Bylaws of the
