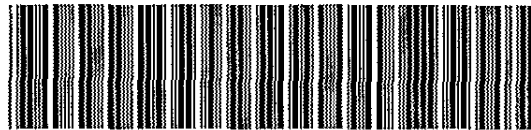

The undersigned natural person of the age of eight years or more for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: The name of the corporation is: Mindtuit Inc.

ARTICLE TWO: The corporation's initial principal place of business and mailing address in the State of Florida is 9402-A Lynn Lane, in the City of Largo, County of Pinellas.

ARTICLE THREE: The purpose of this corporation is to primarily provide bookkeeping and tax services to small to medium sized businesses. In addition, the company will engage in providing third-party accounting and point-of-sale software-hardware consultation and installation to said such businesses. Furthermore, the company may engage in any and every lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE FOUR: The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares of Common Stock without par value.

ARTICLE FIVE: The preemptive right of shareholders other than Benjamin Nasserri to acquire additional shares is subject to approval by the Board of Directors.

ARTICLE SIX: The address of the corporation's initial registered office in the State of Florida is 9402-A Lynn Lane, in the City of Largo, County of Pinellas, and the name of its initial registered agent in charge thereof at the above address is Benjamin Nasserri.

ARTICLE SEVEN: The name and place of residence of the incorporator is as follows:
