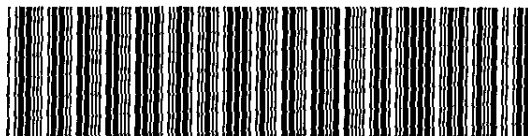

OF

**ARTICLE ONE**

The name of the corporation is: **Kittinger Drywall, Inc.**


