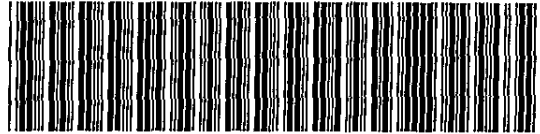

ARTICLES OF INCORPORATION

OF

The undersigned, acting as the incorporator of a corporation under the Florida Business Corporation Act adopts the following Article of Incorporations for such corporation:

ARTICLE I. NAME

The street address in Florida of the corporation's initial registered office is 104 Motes Road, Palatka, Fla. 32177 and the initial registered agent at such address is Richard Day.




