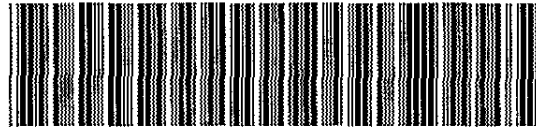

The name of this corporation is M.C. of the Keys, Inc.






