ARTICLES OF INCORPORATION OF SHORE THINGS OF NORTH BEACH, INC.

ARTICLE I - NAME

The name of this corporation is:

SHORE THINGS OF NORTH BEACH, INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation

is:
