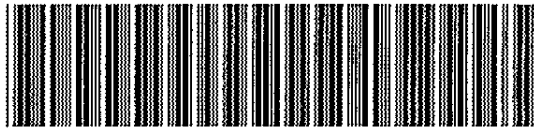



ARTICLE I - NAME

The name of this professional service corporation is Kara Hardin, P.A.

ARTICLE II. DURATION


