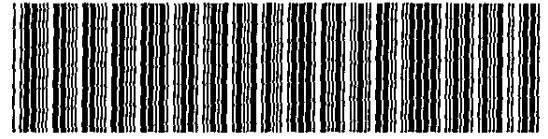



  - Purchase real estate


ARTICLE IX VOTING
