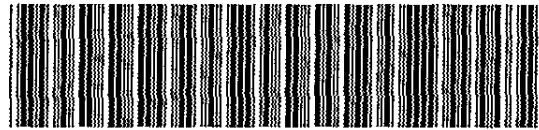

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE 1**

**NAME AND ADDRESS**

Section 1.1 **Name.** The name of the corporation is SKYBAR of SWF, Corp..

Section 1.2 **Address of Principle Office.** The address of the principal office is 2224 Bay St., Ft. Myers, FL 33901.

**ARTICLE 2**

**DURATION**

Section 2.1 **Duration.** This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed, except that if they are not filed by the Department of State of Florida within five business days after they are executed, corporate existence shall commence upon filing by the Department of State.

**ARTICLE 3**

**SHARES**

Section 3.1 **Shares.** The number of shares of stock that this corporation is authorized to have outstanding at any one time is 7000 shares of voting common stock having a par value of \$ 1.00 per share.




