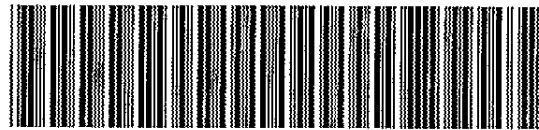

ARTICLE I - Name

The name of this corporation is CARTROY, INC.

ARTICLE II - Duration

The period of its duration is perpetual.
