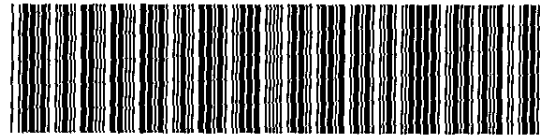

WE, THE UNDERSIGNED, do hereby make, subscribe, acknowledge and file with the Secretary of State of Florida under the Florida Business Corporation Act, Florida Statutes, Chapter 607, these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE ONE

Name. The name of the corporation shall be MOORHOUSE, INC.

ARTICLE TWO

Address. The address of the principal office and the mailing address of this corporation shall be: 675 - 63rd Street South, St. Petersburg, FL 33707.

ARTICLE THREE

Duration. The duration of the corporation is perpetual.

ARTICLE FOUR

Purpose. The corporation may engage in the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE FIVE

Capital Stock. The total number of shares of capital stock authorized to be issued by the corporation shall be 1,000 shares having a par value of \$1.00 per share. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. All or any part of said capital stock may be paid in cash, in property or in labor or services actually performed for the corporation and valued at

a fair valuation to be fixed by the corporate officers at a meeting called for such purpose. All stock when issued shall be paid for and shall be non-assessable.

ARTICLE SIX

Principal Office and Initial Registered Office and Agent. The street address and mailing address of the principal office and initial registered office of the corporation is 675 - 63rd Street South, St. Petersburg, FL 33707, and the name of its initial registered agent at that address is JAMES R. MOORHOUSE.

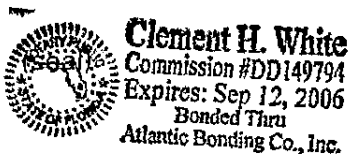




