

ARTICLES OF INCORPORATION

FOR

MacSub XII, Inc.

ARTICLE I NAME

The name of the corporation shall be MacSub XII, Inc.

ARTICLE II
NATURE OF BUSINESS

The purpose of this corporation is to transact all lawful business.

ARTICLE III CAPITAL STOCK
