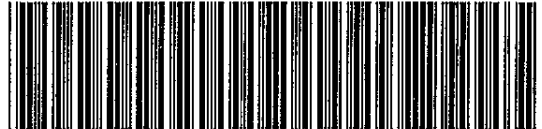





The name of the corporation is Winking Gator Investments, Inc., ("the Corporation"). It was organized under the laws of the State of Florida on February 12th 2003.





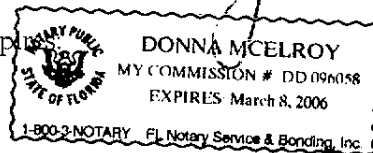
