

ARTICLES OF INCORPORATION OF ALLIANCE BUSINESS SOLUTIONS, INC.

ARTICLE ONE

The name of the corporation is Alliance Business Solutions, Inc., and its principal office is at 2350 N 34th Street N, Suite 110, St. Petersburg, Florida 3371

ARTICLE TWO

The period of its duration is perpetual.
