OSPEN TO THE ST. The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be KOHLER MORTGAGE, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.
