

We, the undersigned, being natural person's, do hereby act as incorporator's in adopting the fallowing articles of corporation for the purpose of organizing a stock corporation pursuant to the provisions of the State of Florida, including particularly, Chapter 607, Florida Statues, and for that purpose, I do herby certify, declare and set as follows, to wit:

#### Article I- Name.
