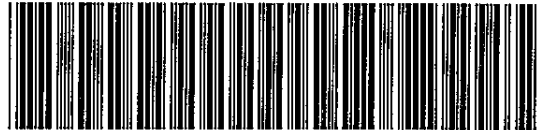

## ARTICLES OF INCORPORATION OF

### ***PRUMAX INTERNATIONAL, INC.***

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby binds himself to form a corporation under the laws of the State of Florida.

**1. ARTICLE I - NAME :**

The name of the corporation shall be:

**2. ARTICLE II - PRINCIPAL OFFICE :**
