Articles of Incorporation

Roffi Vin Import, Inc.

ARTICLE I

NAME

The name of the Corporation is Roffi Vin Import, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal office and mailing address of the Corporation shall be 999
Sunswept Road, NE, Palm Bay, FL 32905.

ARTICLE III

PURPOSE OF CORPORATION

The purposes for which the business of this Corporation shall be conducted are
as follows:

A. To engage in every phase and aspect of the business as determined by
the Board of Directors from time to time including, without limitation, the manufacture,
design, construction, ownership, use, purchase, sale or lease, of articles and property of
all kinds and to render services of all kinds, and to engage in any lawful act or activity
for which corporations may be organized under the laws of the United States and the
State of Florida.

B. To invest the funds of this Corporation in real estate, mortgages, stocks,
bonds, or any other type of investment, and to own real and personal property
necessary to the operation of the Corporation.

C. To do anything necessary and proper for the accomplishment or
furtherance of any of the purposes or objectives of the Corporation.

ARTICLE IV
TERM OF EXISTENCE

The Corporation shall commence on the date these Articles are filed with the Secretary of State, and thereafter shall have perpetual existence unless dissolved according to law.

ARTICLE V
CORPORATE CAPITALIZATION

A. The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred thousand (100,000) shares of common stock having a par value of \$.001 per share.

B. The Board of Directors of the Corporation may authorize, from time to time, the issuance of shares of common stock for such consideration as the Board Of Directors may deem advisable, subject to such restrictions or limitations, if any, as may be set forth in these Articles of Incorporation, as amended, or the Bylaws of the Corporation.

ARTICLE VI
VOTING RIGHTS

Except as otherwise provided by law, the entire power for the election of Directors, and for all other purposes, shall be vested exclusively in the holders of the outstanding shares of common stock.

ARTICLE VII
REGISTERED AGENT

The initial Registered Agent of the Corporation shall be Bruce Hopkins whose business office is identical with the Corporation's registered office set forth below.

ARTICLE VIII

ADDRESS OF REGISTERED OFFICE

The street address of the initial registered office of this Corporation shall be 999 Sunswept Road, NE, Palm Bay, FL 32905.

ARTICLE IX

BOARD OF DIRECTORS

A. The business of this Corporation shall be managed by the Board of Directors. The initial Board of Directors shall have one (1) Director.

B. The number of Directors may be either increased or diminished from time to time by the Bylaws, adopted by the shareholders or Directors, but shall never be less than one (1).

BYLAWS

The power to adopt, amend or repeal the Bylaws of this Corporation shall be vested in the Board of Directors and the shareholders. The Board of Directors shall have the power, without the assent or vote of the shareholders, to make, alter, amend or repeal the Bylaws, but the affirmative vote of a number of Directors equal to a majority of the number who would constitute a full Board of Directors at the time of such action shall be necessary to take any action for the making, alteration, amendment or repeal of the Bylaws.

ARTICLE XI
INDEMNIFICATION

This Corporation shall to the fullest extent permitted by law, as amended and supplemented from time to time, indemnify any and all persons whom it shall have power to indemnify from and against any and all expenses, liabilities or costs, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, agreement, vote of stockholders, or disinterested directors, or otherwise, both as to actions in an official capacity, or to actions in another capacity while holding office, and shall continue as to a person who has ceased to be a director, officer, employee or agent and shall inure to the benefit of the heirs, executors and administrators of any such person.

Subchapter "S" Election

It is the intent of the Incorporator to file the appropriate Subchapter "S" Internal Revenue Code Election (IRS Form 2553) at the Organizational Meeting of the Corporation.
