**ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F. S. Chapter 607, the undersigned, being natural people, hereby act as Incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The Name of the Corporation ("Corporation") is TITAN RELOCATION SERVICES, INC.

ARTICLE II

The existence of the corporation shall begin on February 18, 2003.

ARTICLE III

The street address of the principal office of the Corporation is 824 Forsyth Street, Boca Raton, Florida, 33487.

ARTICLE IV
