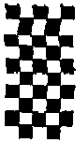

**ARTICLES OF INCORPORATION  
OF  
ACRL SERVICES, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation shall be: **ACRL SERVICES, INC.**

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 8932 48<sup>th</sup> Street, Live Oak, Florida 32060

**ARTICLE III. DURATION**

The duration of this corporation is perpetual.

**ARTICLE IV. PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

#### ARTICLE VII. INITIAL REGISTERED AGENT AND ADDRESS

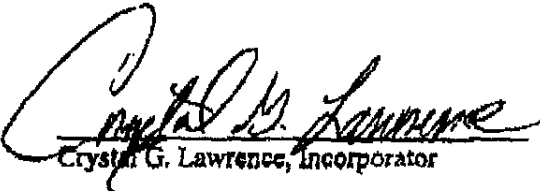

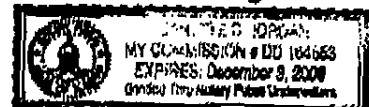

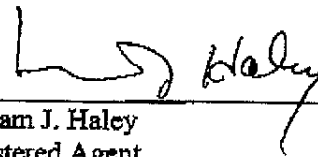
