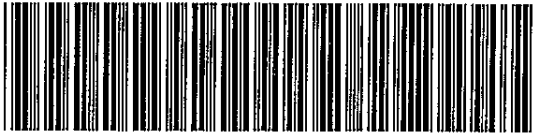


ARTICLE VII. RESIDENT AGENT


