## ARTICLES OF INCORPORATION

BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

- 1. **NAME.** The name of this corporation is Ceramic Tile by Gardner, Inc.
- 2. **TERM**. This corporation shall exist perpetually.
