The undersigned, acting as incorporator of Four Musketeers, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE
