

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article I. Name. The name of the Corporation is LMK Consulting Corp.

Article II. Principal Office. The principal place of business and mailing address is 5317 Fruitville Road #213, Sarasota, Florida 34232.

Article III. Duration. The duration of the Corporation is perpetual.

Article IV. Purpose. The general purpose for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
