### ARTICLE I

#### NAME

The name of the Corporation is Trawick & Sons, Inc.. The principal office address and the mailing address of said Corporation is 1145 Mill Creek Drive Jacksonville, Florida 32259.

### ARTICLE II

#### DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

### ARTICLE III

#### PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may hereafter be amended.

## ARTICLE IV

### CAPITAL STOCK

This corporation is authorized to issue 1000 shares of \$1.00 par value stock which shall be designated as "Common Stock", with stock issued based on IRS Code Section 1244.

## ARTICLE V

### PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

## ARTICLE VI

### INITIAL REGISTERED OFFICE AND AGENT

## ARTICLE VII

### INITIAL BOARD OF DIRECTORS

### INDEMNIFICATION






