ARTICLES OF INCORPORATION

OF

GOLD DAWG PIZZA, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation is GOLD DAWG PIZZA, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PRINCIPAL OFFICE

The street address of the principal office of the corporation is 3906 Alamanda Drive, Sarasota, FL 34238.

ARTICLE IV - PURPOSES

The purposes for which the corporation is organized are:

- A. To provide food services and related businesses.
