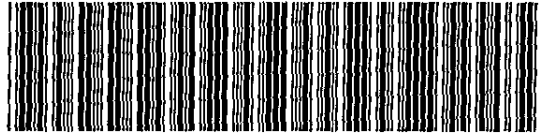

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607 of the Florida Statutes, adopts the following Articles of incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is **VICTORY GRAPHICS, INC.**

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III - TERM OF EXISTENCE

This corporation shall exist perpetually. This corporation shall commence its existence as of March 1, 2003.

ARTICLE IV - CAPITAL STOCK

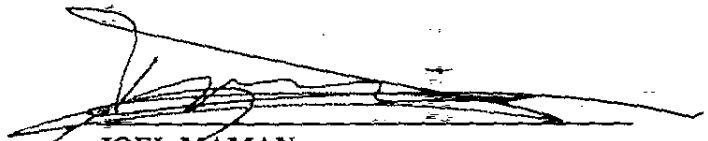
ARTICLE VII - INDEMNIFICATION

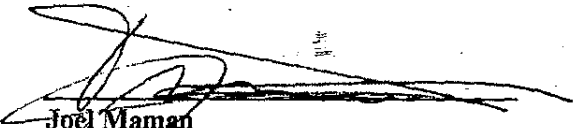
