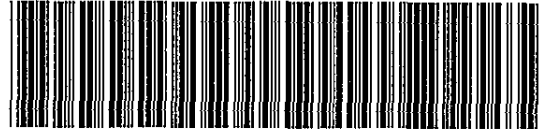

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I

Name and Address

- Section 1. The name of the Corporation shall be Discovery Relief, Inc.
- Section 2. The address of the principal office of the Corporation is 3101 30th Street North, St. Petersburg, Florida 33713.
- Section 3. The mailing address of the Corporation is P. O. Box 60673, St. Petersburg, Florida 33784.

ARTICLE II

Purpose and Powers

- Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.
