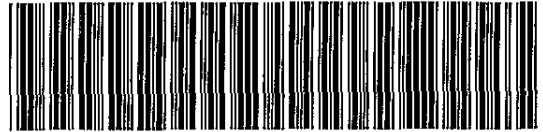

ARTICLES OF INCORPORATION

OF

GINA A. DURNAK, P.A.

The undersigned does hereby form a corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I. – NAME OF CORPORATION

The name of the corporation shall be: GINA A. DURNAK, P.A.

ARTICLE II. – PRINCIPAL PLACE OF BUSINESS

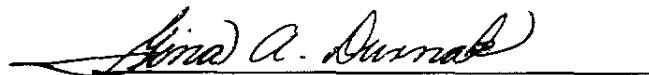
