

**ARTICLES OF INCORPORATION**  
**SaveOn MEDICAL SUPPLIES, INC.**

**ARTICLE I**

The name of this corporation is SaveOn MEDICAL SUPPLIES, INC. Whose principal address is 9011 NW 7th Court, Pembroke Pines, Florida 33024

**ARTICLE II**

The general nature of the business to be transacted by this corporation is to engage in the medical supplies, a business permitted under the laws of the State of Florida.

**ARTICLE III**

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.

**ARTICLE IV**

This Corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation.



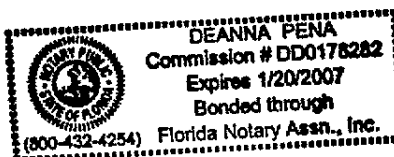
