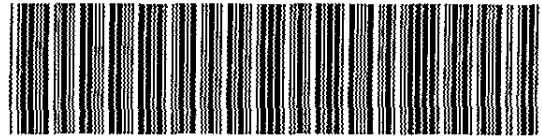

**ARTICLE I**

**Name**

The name of the corporation is Cipsade Miami, Inc. (hereinafter called the "Corporation").



This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by any law in existence either now or hereafter.


